Executive Orders Issued to Flatten the Curve

Since Kentucky saw its first coronavirus case in March, Kentucky Gov. Andy Beshear has been issuing executive orders to protect Kentuckians from the spread of COVID-19.

At the time this newsletter was published, all of those executive orders remain in place. Below is a full list of the steps that have been taken at the state level to address the pandemic.

- A State of Emergency has been declared
- Schools and daycare centers across Kentucky have been closed until further notice
- The waiting period and work requirements for unemployment insurance benefits have been waived

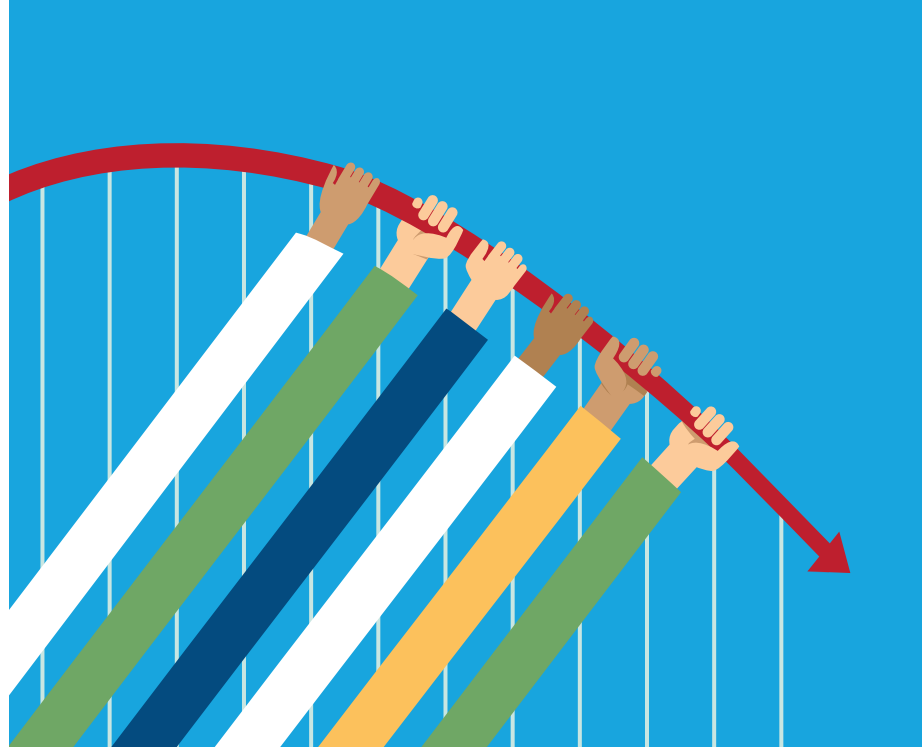

Flatten the Curve

- Unemployment insurance benefits have been extended to self-employed Kentuckians and contract workers
- Restaurants and bars across the state have been closed to in-person service and are instead focusing on drive-thru, pickup, and delivery options
- All non-essential retail has been asked to closed to in-person traffic but can utilize curbside pickup
- Any non-life-sustaining businesses were asked to move to only telework and only have people in the office to handle “essential office functions”
- Gyms, hair and nail salons, and other businesses have been asked to closed
- Travel outside of Kentucky is prohibited except for medical needs, care of a loved one, or very few other reasons
- Copays, deductibles, cost-sharing, and diagnostic testing fees for private insurance and state employees has been waived and providers must expand their networks so patients can get what they need
- Medicaid eligibility has been extended to those losing their employment because of COVID-19 and the wait period has been waived
- Pharmacies can refill prescriptions for up to 30 days to ensure vulnerable communities or those who need to self-isolate will have needed prescriptions
- Kentucky Employers' Mutual Insurance is providing wage replacement benefits to first responders and medical personnel who have been quarantined for COVID-19

Primary Election MOVED TO JUNE

The primary elections have been moved from May 19 to **June 23, 2020** following an executive order by the governor in March. Now, after recommendations from Kentucky Secretary of State Michael Adams, Gov. Andy Beshear issued a new executive order to change the way votes will be cast on the new date.

The executive order states all Kentuckians will be able to utilize absentee voting by mail if they are able to do so. To accomplish this, the State Board of Elections will create an online portal that will allow voters to request the absentee ballot be mailed to them and will also be sending out a postcard to every registered voter in Kentucky informing them of this new ability and the process.

As for in-person voting, the order states in-person absentee voting will begin on June 8 and clerks will be encouraged to prioritize such voters by appointment. Clerks and poll workers will be provided with personal protective equipment and proper sanitization and work will be done to ensure minimal contact between individuals during the voting process which could include drive through voting.

SURVEYS SHOW KENTUCKY BUSINESSES MAKE DECISIONS TO *Protect Employees Amid Tough Financial Decisions*

As America has been battling to control the coronavirus pandemic, governments continue to place restrictions on businesses, greatly impacting their day-to-day operations.

In order to assess how the pandemic has affected Kentucky business owners and their employees, the Kentucky Chamber of Commerce has conducted two statewide surveys since March 16, 2020 asking business leaders how they are managing amid this new environment.

Results show most businesses letting employees work from home, completely halting travel for all employees, and providing paid leave. Companies have also had to eliminate costs, lay off employees, and take additional precautions to protect Kentuckians from spreading the virus.

According to the results, it is not just restaurants and retail that have had to lay off employees and make serious decisions about their finances. Businesses of all

sizes and industries noted the financial hit their company is taking as a result of lost business and revenue.

Working from home measures seem to vary greatly by industry. While most companies with operations mainly centered around office work have been able to let their employees work from home, manufacturers, health care companies, and others have not been able to do so.

To address this and ensure the safety of their employees that have to come into the facility to complete their job duties, companies detailed efforts to deep clean and sanitize their workspaces with increased frequency, enforce CDC guidelines for social distancing and the number of people in an area at one time, staggering work schedules, and much more. Some employers are also doing frequent health checks/screenings of employees to protect the individual and the rest of their workforce.

STATE AND BUSINESS LEADERS FOCUS ON TALENT DEVELOPMENT AND REENTRY INITIATIVES AT *2020 Kentucky Workforce Summit*

While finding and retaining the right employees continues to be a top priority for Kentucky businesses, state leaders and experts shared best practices and initiatives to address critical workforce and education issues at the 5th Annual Kentucky Workforce Conference.

Kentucky Education and Workforce Development Cabinet Deputy Secretary Josh Benton said while Kentucky is leading the nation in tackling workforce issues, there is more work to be done as Kentucky businesses still struggle to find employees.

As the Kentucky Chamber Workforce Center is in its second year of implementing Talent Pipeline Management systems across the Commonwealth, panels of industry experts shared their initial experiences with using the TPM system. Panels of health care and construction experts discussed finding employees in their evolving industry and shared their successes with the TPM system, which has led to businesses building relationships with education providers to recruit students as potential future employees.

Kentucky companies have created new ways to find and develop talent while experiencing the workforce shortage. The leaders of Murakami Manufacturing and Logan Aluminum talked about their methods to solving the talent gap by retaining valuable employees and building pipelines to future workforce through community partnerships.

Businesses have experienced the effects of the opioid epidemic, recognizing it is one of the top barriers to employment. Jason Merrick, director of addiction services for Kenton County Detention Center, said it is essential to eliminate the gap between incarceration and employment with education, job skills, and basic life training. He stressed the importance of a solid road for recovery with reentry programs and second chances.

KENTUCKY DISTILLERS' ASSOCIATION MEMBERS *Donate More Than 125,000 Gallons of Hand Sanitizer to Critical Areas*

Nearly 80 years ago, Kentucky's signature Bourbon and distilled spirits industry stepped up by producing industrial alcohol to help safeguard the country and its citizens during World War II.

Today, distillers are once again answering the call in the fight against another war – the COVID-19 pandemic – where people's lives and livelihoods are at stake.

In the last few weeks, members of the Kentucky Distillers' Association have produced and donated more than 125,000 gallons of desperately needed hand sanitizer to frontline workers, first responders, hospitals

and health care facilities across the state.

KDA distillers – from the largest to the smallest – quickly retooled their facilities and began donating sanitizer by priority requests made through the KDA's portal at www.kyhandsanitizer.com, in partnership with the Kentucky Chamber of Commerce.

To put the amount into perspective, KDA President Eric Gregory said 125,000 gallons of hand sanitizer would equal more than 630,000 "fifths" of whiskey, or 750ml bottles as they are labeled today.

Distillers were able to produce sanitizer relatively quickly because the main ingredient is alcohol.

As requests started pouring in, the KDA promptly issued best practices for sanitizer production, including the requirement that members follow Food and Drug Administration guidelines for production and labeling that are consistent with the

World Health Organization sanitizer formulation.

However, not all regulatory hurdles have been cleared. Most distillers began sanitizer production knowing that the product could face expensive federal excise taxes, the same as they pay on their world-famous whiskey.

Though Congress eventually provided temporary relief for the tax burden as part of its Coronavirus Relief Package, the FDA has not provided flexibility in its guidance to allow distillers to recognize this tax relief while also making hand sanitizer in an efficient and effective manner.

Some of the larger distilleries could face hundreds of thousands of dollars in tax liability on donated hand sanitizer if the FDA does not act, Gregory said.

The KDA continues to work alongside the Distilled Spirits Council of the United States, the American Craft Spirits Association and other partners to encourage action by the FDA so that distillers can make more hand sanitizer and be eligible for tax relief.

Producing and distributing more than 125,000 gallons in a few weeks' time took a tremendous collaborative effort, said KDA Chairwoman Jessica Pendergrass, General Counsel at Heaven Hill Brands.

"Our members have proven time and time again that we can accomplish more by working together," she said. "And the truest test of a signature industry is how we support each other and our communities to respond in times of crisis.

"We are proud of how the KDA and its distillers have stepped up to help."

Kentucky Governor Andy Beshear said, "These companies worked quickly and tirelessly to source the materials and manufacture this essential product for Kentuckians fighting on the front lines of this pandemic.

"I am grateful and proud to have the KDA and its members on Team Kentucky."

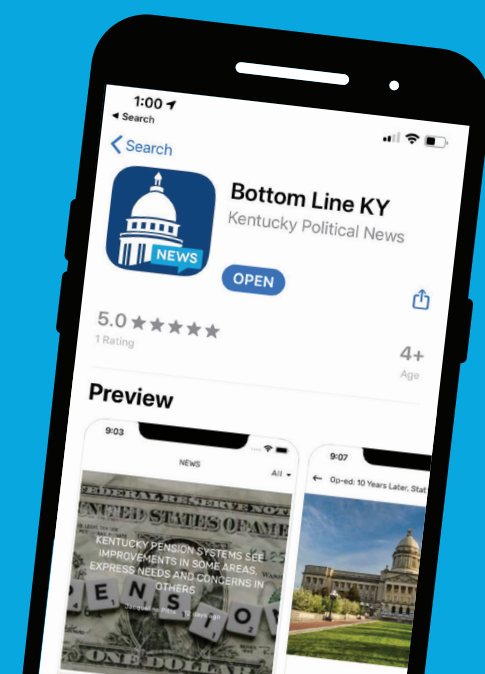

NEW MANDATORY LABOR LAW NOTICE RELEASED:

Families First Coronavirus Response Act Notice

On March 25, 2020, the Department of Labor issued notices that employers must post to comply with the Families First Coronavirus Response Act (FFCRA). The DOL has issued one notice for covered private sector employers and a separate poster for federal government employers.

FFCRA will help the United States combat and defeat COVID-19 by reimbursing American private employers that have fewer than 500 employees with tax credits for the cost of providing employees with paid leave taken for specified reasons related to COVID-19. The legislation will ensure that workers are not forced to choose between their paychecks and the public health measures needed to combat the virus, while at the same time reimbursing businesses.

The Kentucky Chamber will be releasing a COVID-19 poster that includes the FFCRA notice, a notice from OSHA with steps employers can take to reduce the risk of exposure to the coronavirus, and notices from the CDC on stopping the spread of germs.

COVID-19 LABOR LAW NOTICES

ALL EMPLOYEES: Your rights as an employee are protected by state and federal laws and regulations. To help make you aware of your rights, your employer is displaying these notices in compliance with these laws and regulations. If you have any questions or need to clarify something you read here, please contact your immediate supervisor or the personnel department.

Ten Steps All Workplaces Can Take to Reduce Risk of Exposure to Coronavirus

All workplaces can take the following infection prevention measures to protect workers:

- 1 Encourage workers to stay home if sick.
- 2 Encourage respiratory etiquette, including covering coughs and sneezes.
- 3 Provide a place to wash hands or alcohol-based hand rubs containing at least 60% alcohol.
- 4 Limit worksite access to only essential workers, if possible.
- 5 Establish flexible worksites (e.g., telecommuting) and flexible work hours (e.g., staggered shifts), if feasible.
- 6 Discourage workers from using other workers' phones, desks, or other work tools and equipment.
- 7 Regularly clean and disinfect surfaces, equipment, and other elements of the work environment.
- 8 Use Environmental Protection Agency (EPA)-approved cleaning chemicals with label claims against the coronavirus.
- 9 Follow the manufacturer's instructions for use of all cleaning and disinfection products.
- 10 Encourage workers to report any safety and health concerns.

What you should know about COVID-19 to protect yourself and others

Know about COVID-19

- Coronavirus (COVID-19) is an illness caused by a virus that can spread from person to person.
- The virus that causes COVID-19 is a new coronavirus that has spread throughout the world.
- COVID-19 symptoms can range from mild (or no symptoms) to severe illness.

Know how COVID-19 is spread

- You can become infected by coming into close contact (about 6 feet or two arm-lengths) with a person who has COVID-19. COVID-19 is primarily spread from person to person.
- You can become infected from respiratory droplets when an infected person coughs, sneezes, or talks.
- You may also be able to get it by touching a surface or object that has the virus on it and then by touching your mouth, nose, or eyes.

Protect yourself and others from COVID-19

- There is currently no vaccine to protect yourself. The best way to protect yourself is to avoid being exposed to the virus that causes COVID-19.
- Stay home as much as possible and avoid close contact with others.
- Wear a cloth face covering that covers your nose and mouth in public settings.
- Clean and disinfect frequently touched surfaces.
- Wash your hands often with soap and water for at least 20 seconds, or use an alcohol-based hand sanitizer that contains at least 60% alcohol.

Practice social distancing

- Buy groceries and medicine, go to the doctor, and complete banking activities online when possible.
- If you must go in person, stay at least 6 feet away from others and disinfected items you must touch.
- Get deliveries and takeout, and limit in-person contact as much as possible.

Prevent the spread of COVID-19 if you are sick


- Stay home if you are sick, except to get medical care.
- Avoid public transportation, ride sharing, or taxis.
- Separate yourself from other people and pets in your home.
- There is no specific treatment for COVID-19, but you can seek medical care to help relieve your symptoms.
- If you need medical attention, call ahead.

Know your risk for severe illness

- Everyone is at risk of getting COVID-19.
- Certain adults and people of any age who have serious underlying medical conditions may be at higher risk for more severe illness.
