

Kentucky's Pro-Growth **POLICIES CREATE MORE JOBS, HIGHER INCOMES & GREATER BUSINESS CONFIDENCE**

Two recent studies conducted by the Kentucky Chamber of Commerce show that business confidence is growing among Kentucky business leaders and that Kentucky is growing faster in jobs, incomes and population than most of its bordering states. The Chamber believes that recent pro-growth policy changes in Kentucky (for example, Kentucky moving this year from ranking 33rd to 23rd among states in our tax structure) will build

momentum and lead to even greater progress for Kentuckians.

In a recent survey of business leaders across the state, nearly 700 responded, and 63% said Kentucky was on the "right track" compared to only 49% who responded the same way in 2015. Their outlook on the state's economic conditions was up dramatically in the same period, from 66% who responded "excellent, very good or good" compared to 41% in the previous survey. While there were regional variances in economic performance and business attitudes, clearly optimism is up.

Another recent report by the Kentucky Chamber, conducted by emeritus University of Louisville economics professor Dr. Paul Coomes, looked at Kentucky's economic performance from the end of the recession in 2009 to 2017. That report brought news that Kentucky has posted more growth in jobs, population and wages than half its bordering states. While we continue to trail the nation in those categories – a reality that describes most of Middle America compared to the growth in coastal and more urban areas – and we trail Indiana and Tennessee, two states that were faster to implement various pro-growth policies, the state of Kentucky is on a positive growth trajectory. That trajectory, combined with business confidence, will fuel economic momentum in the years ahead.

When viewing these findings of the surveys together, two things are clear: Kentucky still faces significant economic challenges, but the business community is optimistic about the state's ability to meet those challenges to build a stronger future. Enacting pro-growth policies, improving the state's tax structure, eliminating outdated regulations and sustaining business confidence will allow Kentucky to continue its growth and build momentum for the next generation.

LEGISLATIVE PRIORITIES

BOLD STEPS FORWARD

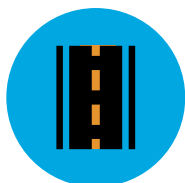
In 2015 the Kentucky Chamber published its strategic plan, *"Four Pillars for Prosperity,"* with a focus on the state's economy and job creation. In recent years we've seen progress on many key business priorities, but there is still more work to be done.

The Kentucky Chamber's 2019 Legislative Priorities outlines the bold steps needed to move Kentucky forward to become more competitive, prosperous, and business-friendly. These priorities were determined by our members through survey, research and discussion and ultimately voted on by our five policy councils and Board of Directors. These priorities serve as the plan of work for our Public Affairs team as they advocate on behalf of our membership during the 2019 session of the Kentucky General Assembly.



Workforce Government Infrastructure Jobs

INVEST IN KENTUCKY'S INFRASTRUCTURE
 Kentucky's transportation network of roads, bridges, airports, riverports, and railroads connect Kentucky businesses to the national and international marketplace by providing multiple safe, cost-effective ways to move goods and deliver services. The Chamber strongly supports legislation that provides consistent long-term funding for maintenance and improvements of transportation infrastructure.



CONTINUED IMPROVEMENT TO KENTUCKY'S TAX CODE
 The Chamber urges continued improvements to Kentucky's tax code to increase competitiveness, including repealing the mandate for unitary combined reporting and revising the limited liability entity tax.



MODERNIZE KENTUCKY'S UNEMPLOYMENT INSURANCE SYSTEM
 The Chamber supports reforms to Kentucky's unemployment insurance benefit structure to keep costs and benefits competitive with other states and increase workforce participation. Further, the Chamber supports efforts to provide those out of work with access to training and career counseling.



IMPROVE KENTUCKY'S LEGAL LIABILITY CLIMATE
 Frivolous lawsuits create increased costs for consumers and an inability to attract and retain a sufficient number of physicians in the Commonwealth. The Chamber supports legal liability legislation to stabilize our judicial system and make the state more attractive to employers.



REFORM KENTUCKY'S BAIL SYSTEM
 In 2016, there were 64,123 non-violent, nonsexual defendants detained in Kentucky because they could not afford bail. In 2017, local governments lost \$152 million because of the current bail system. The Chamber supports reforms to Kentucky's bail system, transitioning the system to focus on the offense and offender and not on their financial means.



ENCOURAGE RESPONSIBLE CONSUMPTION
 The Chamber encourages responsible consumption and supports continuing responsibility efforts geared toward underage drinking and DUI offenders.



ENSURE AFFORDABLE ENERGY RESOURCES
 The Chamber supports legislation that ensures the costs to support and maintain infrastructure are allocated fairly among all users. Outdated policies adopted to incentivize new technologies, such as distributed solar generation, should be re-examined to ensure all the costs to support and maintain reliable operation of the energy infrastructure are shared fairly.



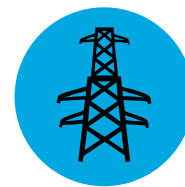
ENACT TOBACCO-FREE SCHOOLS
 Kentucky high school youth tobacco rates are 62% higher than the national average. If we are to strengthen both educational outcomes and health for tomorrow's workforce, we must prevent our youth from becoming addicted to tobacco. To help curb this trend, the Chamber supports prohibiting tobacco use from all Kentucky school properties.



ENACT SPORTS WAGERING
 After a decision by the United States Supreme Court in May opening the door for states to allow bets on sporting events, the Chamber supports allowing sports wagering in Kentucky. This legislation must protect existing signature industries and racing facilities.



ENCOURAGE COMPETITIVE BROADBAND CLIMATE
 The Chamber encourages a competitive business climate that motivates broadband deployment.



CLARIFY ARBITRATION STATUTE
 With a recent Kentucky Supreme Court decision, Kentucky is now the only state that prohibits an arbitration agreement as a condition of employment. The Chamber supports clarifying Kentucky's arbitration laws to ensure that private business can continue with the common practices of arbitration agreements.

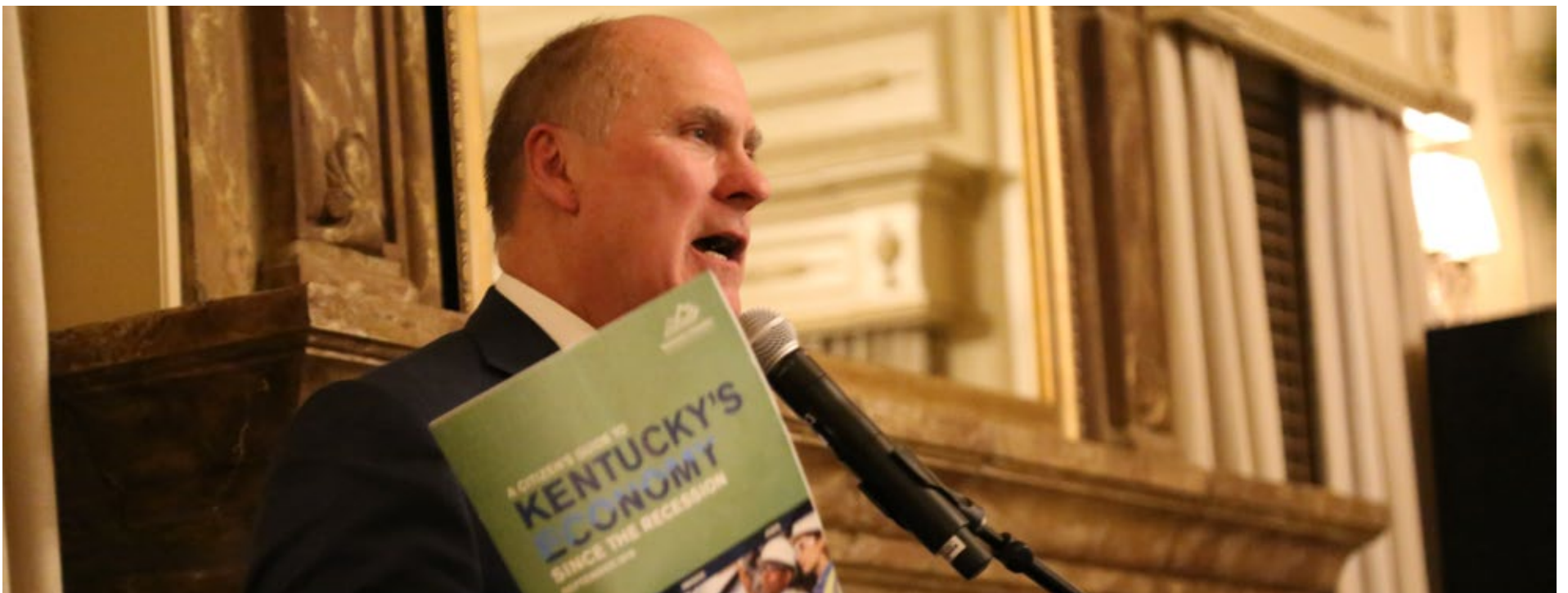
Nick Rowe, President of Kentucky American Water, will serve as Chairman-Elect for 2020.

Craft Leads

Craft also highlighted the role of the business community in critical pension reforms and the beginning of reforms to Kentucky's tax code, two things he said are crucial for the future of Kentucky.

"We're seeing action; we're getting results, and that's going to pay huge dividends. We've got to grow our state," Craft said. "We've got to embrace growth and that means that we've got to identify what we can do to attract businesses. And I think we're doing a good job with that."

In discussing why he feels membership in the Kentucky Chamber is vital, Craft said the Chamber is the one organization where the business community can come together and have an active dialogue about the issues critical to the state and make a difference.

"I'm just so pleased that our business leaders will actively engage and will engage in that dialogue, will take their time and understand the importance of talking one to another as opposed to just going directly to the legislature," Craft said, adding the business community coming together as one voice through the Chamber is a key aspect of getting policies passed through the General Assembly.

As for the future of the Chamber's efforts, Craft said he sees the business

community continuing to push for economic progress across the state through advocacy efforts and other initiatives, remaining involved in political races, and an ongoing push to be a vital voice in a divided atmosphere. Craft pointed to the keynote address of Arthur Brooks at the 2018 Kentucky Chamber Annual Meeting as an example of that voice.

"We've got to come together. We've got to bring our ideas together because we're on the right path as a state, we're on the right path, and we need people trying to pull us forward instead of pull back," Craft said.

In 2017, Craft's wife, Kelly was appointed Ambassador to Canada by President Donald Trump. When asked how his family has juggled his role as CEO of a large company, his chairmanship with the Chamber, and his wife's role as Ambassador, Craft said they were thrilled to be representing the Commonwealth in these critical roles and enjoy working hard to achieve progress.

Reflecting on his year overall, Craft said he was humbled by the opportunity to serve as chair of the Kentucky Chamber and described it as a great experience.

"I would encourage any CEO to truly to get involved. I think leadership matters and I think by being engaged and coming to the chamber knowing you're going to be a warrior, knowing that you're going to be a participant, knowing that you've got something to bring to the table, that's what we need. We need active participants," Craft said.

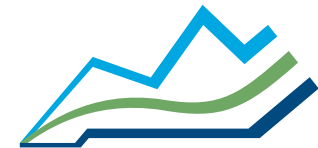

Change In Road Funding Formula

MUST BE ACHIEVED IN 2019 SESSION, REP. SANTORO EXPLAINS

As Kentucky struggles to maintain roads and bridges in its 120 counties and faces a decrease in funding from the federal government, House Budget Review Subcommittee on Transportation Chair Sal Santoro says reforms must come in the 2019 session because "Kentuckians deserve better."

Santoro noted the 2018 session was filled with many difficult and controversial issues including comprehensive tax reform and changes to the state's pension systems that made it difficult to take up an issue like changing the formula for how transportation funds are collected.

He said, however, that transportation funding is critical in Kentucky as roads and bridges need repair throughout the state and pointed to the fact that the state's General Fund, where most government services are paid, and the Road Fund are separate and Kentucky's infrastructure has been neglected as a result of a lack of changes to that fund.

Santoro explained the formula for maintaining and building infrastructure in the state is funded in large part through the gas tax and he said on average, \$150 to \$160 is collected per year from an individual through the gas tax in the state of Kentucky. Santoro said that while many get upset with the prices at the pump because it is something they are seeing frequently and watching fluctuate, those price changes have a huge impact on what the state's roads and bridges look like.

"I hear complaints when people call and they say 'potholes are here, why aren't we fixing potholes?' Well, [when] the price of gas went down, that means less money is going into the road formula for maintenance," Santoro said.

The bill sponsored by Santoro during the 2018 session to increase infrastructure funding through changes to the formula would have increased the gas tax by a small amount as well as implemented some fees on electric vehicles at registration and/or purchase to ensure everyone is paying their fair share for the roads even if they aren't paying at the pump.

Santoro says it is also critical to pass legislation to increase this type of funding because if Kentucky does not pass reforms, the state will also begin to lose even more federal transportation funding, making it even harder to fix existing Kentucky's roads and bridges, as well as build new infrastructure.

"I just want everyone to understand that this is a consumption fee. That's all it is. You purchase your fuel, you want to be able to say I am now going to drive on safe highways and safe bridges. If we don't do something in order to build these roads and make these bridges safe, there will be no funding," Santoro said.

Thirty-Nine Local Leaders Selected

FOR ACADEMY TO ADDRESS WORKFORCE NEEDS ACROSS KENTUCKY

Thirty-nine leaders of business, industry, and education from across the state have been named as the first Champions selected to attend Kentucky's Talent Pipeline Management (TPM) Academy.

Earlier this year, Kentucky was designated by the U.S. Chamber Foundation and the W.K. Kellogg Foundation as one of three states to implement the academies, and the Kentucky Chamber Workforce Center was chosen to carry out the TPM initiative in the Commonwealth.

Talent Pipeline Management is an employer-led approach to identifying specific workforce needs as well as training and quality issues and solutions to persistent workforce-related challenges. The TPM Academy is a three-part program to train Champions on ways to build talent supply chains and launch TPM in their own communities.

Since achieving the TPM designation, the Chamber's Workforce Center has focused on engaging employers to work together on a sector and regional basis to address their workforce needs. The work is being done with the support of the Strada Education Network, a national nonprofit and the founding partner of the Kentucky Chamber Workforce Center, and in partnership with the Kentucky Education & Workforce Cabinet.

The Workforce Center's Talent Pipeline staff and the Champions selected for the TPM academy will focus on creating specific strategies to meet the needs of different industry and regional sectors. By July 2020, more than 25 employer groups, representing regions as well as business and industry sectors, are to be convened to build talent pipelines for 75 high-demand positions.

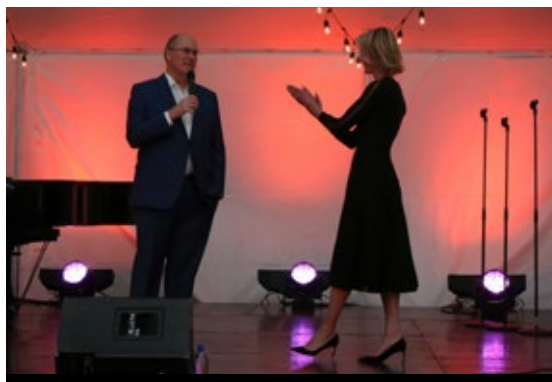

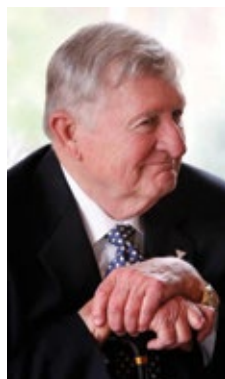
