

2016 KYSHRM EXHIBITOR & SPONSOR TERMS

- 1. <u>Contract Conditions</u>. These exhibition regulations shall apply to the exhibitor and/or sponsor ("Exhibitor/Sponsor") identified on the Exhibitor/Sponsor Application/Contract, for the 2017 Kentucky Society for Human Resource Management Conference (the "Conference"), which has been received by the Kentucky Chamber of Commerce ("Chamber").
- 2. <u>Exhibition Space</u>. Exhibition space will be assigned by Chamber on a first-come, first-serve basis to exhibitors who complete and return the Application/Contract with payment; however, Chamber reserves the right to reassign exhibition booth space if necessary. Chamber reserves the right to refuse exhibition booth space to any potential exhibitor.
- 3. <u>Exhibition Space Rental</u>. Chamber must receive Exhibitor's/Sponsor's payment in full by June 2, 2017 to reserve Exhibitor's/Sponsor's exhibition booth space. Such payment may be mailed to the address set forth on the Application/Contract.
- 4. <u>Set Up/Tear Down</u>. Exhibitor/Sponsor set up is Tuesday, August 29, 2017 from 10 a.m. to 4:30 p.m. Tear down and move out is Wednesday, August 30, 2017 from 4 p.m. to 6 p.m.
 - 5. Booth Staffing. A representative of Exhibitor/Sponsor must occupy its booth during all scheduled exhibit hours of the Conference.
- 6. <u>Conference Cancellation</u>. Chamber reserves the right to cancel the Conference if it is deemed necessary. In the event of any such cancellation, Chamber will refund Exhibitor's/Sponsor's payment in full, and Exhibitor/Sponsor shall waive any and all damages and claims for damages in connection with such cancellation.
- 7. <u>Exhibitor/Sponsor Cancellation</u>. Prior to June 2, 2017, Exhibitor/Sponsor may withdrawal from the Conference and receive a full refund less a Fifty Dollar (\$50.00) administrative fee. Chamber will not provide any refund if Exhibitor/Sponsor withdrawals after June 2, 2017.
- 8. <u>Fire Prevention/Safety</u>. All display material used in any exhibit must be flame retardant. All electrical wiring must be in good condition, must conform to local fire regulations and must be able to pass inspection by the fire marshal. In addition, Exhibitor/Sponsor shall take precautions for the safety of other exhibitors and all other persons attending the Conference.
- 9. <u>Shipping</u>. Chamber will forward shipping information to Exhibitor/Sponsor upon receipt of the Application/Contract. All shipments will be at Exhibitor's/Sponsor's own risk and expense, and must be prepaid.
- 10. <u>Electric</u>. Chamber will forward information regarding electrical needs to Exhibitor/Sponsor upon receipt of the Application/Contract. Exhibitor/Sponsor will be charged for any electrical needs.
- 11. <u>Insurance</u>. Exhibitor/Sponsor acknowledges that the Chamber, Kentucky Society for Human Resource Management ("SHRM") and the Galt House Hotel do not maintain insurance covering Exhibitor's/Sponsor's property. If Exhibitor/Sponsor desires to insure its exhibit materials, goods, and/or equipment against theft, damage by fire, accident, or loss of any kind, it shall do so at its own expense.
- 12. <u>Liability</u>. Exhibitor/Sponsor hereby agrees to indemnify, defend and hold harmless the Chamber, SHRM and the Galt House Hotel, and each of their officers, directors, employees and agents from and against any actions, law suits, costs, damages, claims and expenses (including attorneys' fees) arising from any damage to property or bodily injury to Exhibitor/Sponsor, his agents, representatives, employees, or any other persons by reason of the Exhibitor's/Sponsor's occupancy or use of the exhibition facilities.
 - 13. Assignment. Exhibitor/Sponsor shall not assign or sublet any of its assigned exhibition booth space.
- 14. <u>Enforcement</u>. Exhibitor/Sponsor agrees to comply with the regulations contained herein, and any rules and regulations set forth by the Galt House Hotel. Chamber reserves the right to evict Exhibitor/Sponsor in the event of any violation of these regulations. In addition, Chamber reserves the right to prohibit Exhibitor/Sponsor from displaying all, or any part, of an exhibit that is deemed unsuitable for the Conference by Chamber.
- 15. <u>Amendments</u>. Chamber reserves the right to amend these regulations at any time, as it deems necessary. Chamber shall have the full power to interpret and enforce all of the regulations contained herein.
