The declaration must name the county you live in for Individual Assistance. To see if your county has been declared, visit www.disasterassistance.gov.

- Enter your city and state or ZIP code in the Look-up box on the Home page and click Look-up. This will take you to the Address Look-up page.
- Once on the page, you will see your county and disaster name listed under "Declared Counties" if it is declared.

Application Checklist

Before you start your FEMA application, please have the information below and a pen and paper ready.

- Social Security Number: You, another adult member or minor child in your household must have a
 Social Security number. You or they must also be a U.S. citizen, non-citizen national, or qualified
 alien. If you don't have a Social Security number, read the article How do I apply for a new or replacement Social Security number card. You will get instructions on what to do and what
 documents you will need. Once you have your number, you may come back
 to DisasterAssistance.gov or call FEMA at one of the phone numbers above to apply.
- **Insurance Information**: Describe the type(s) of insurance coverage you have. This could include coverage under policies like homeowners, flood, automobile, or mobile home insurance.
- Damage Information: Describe the damage caused by the disaster. Include the type of disaster (like flood, hurricane, or earthquake) and the type of dwelling or vehicle (like a condo, mobile home or house, or a car or truck).
- **Financial Information:** Provide your total annual household income, before taxes, at the time of the disaster.
- **Contact Information:** Provide the address and phone number of the property where the damage occurred and the address and phone number of where we can reach you now.
- **Direct Deposit Information (optional):** If approved, we can deposit your funds directly into your bank account. You just need to provide the following banking information:
 - o Bank name
 - Type of account (like checking or savings)
 - Routing number
 - o Account number

DISASTER UNEMPLOYMENT ASSISTANCE



Individuals who became unemployed or those who are self-employed and had work interrupted in 14 Kentucky counties as a direct result of the severe storms, straight-line winds, flooding, and tornadoes on December 10, 2021, are eligible to apply for Disaster Unemployment Assistance (DUA) benefits through the Kentucky Office of Unemployment Insurance:

 Caldwell, Christian, Fulton, Graves, Hart, Hickman, Hopkins, Logan, Lyon, Marshall, Muhlenberg, Ohio, Taylor, and Warren.

In order to qualify for DUA benefits, claimants in eligible counties must show that their employment or self-employment was lost or interrupted as a direct result of the disaster and that they are not otherwise eligible for traditional unemployment insurance benefits under state or federal law.

- Farmers and other self-employed individuals who are traditionally ineligible for unemployment insurance (UI) benefits may qualify for DUA.
- Individuals will need their Social Security number, a copy of their most recent Federal income tax forms or check stubs. To receive DUA benefits, all required documentation must be submitted within 21 days from the day the DUA application is filed.
- Affected individuals should visit the Kentucky Career Center website (kcc.ky.gov) or call (502) 875-0442 to file their initial claim. The deadline to apply for assistance is January 18, 2022.
- After claimants apply for UI benefits, they should attend an in-person session at one of the following locations Monday through Wednesday, December 21 – December 22 between the hours of 8:00 AM to 5:00 PM:

Additional days and times will be available from December 27 through December 29 at locations that are still being finalized. Updated information will be communicated on the Kentucky Career Center website (KCC.ky.gov) and future press releases with detailed information.

When filing a claim in-person, self-employed individuals should bring a copy of their 2020 income
tax return. All applicants filing for disaster benefits need to supply photo identification, a bill
showing your physical address at the time of the disaster, and current mailing address
confirmation if changed.

FOOD ASSISTANCE (SNAP)

The Disaster Supplemental Nutrition Assistance Program (D-SNAP) gives food assistance to low-income households with food loss or damage caused by a natural disaster.

Note the following temporary changes to SNAP benefits policies:

Current SNAP beneficiaries can call the Department for Community Based Services (DCBS) at 855-306-8959 or visit their county's DCBS office to request replacements for food lost due to the storms or related power outages. Replacements can be requested until Jan. 8, 2022.

Some residents of Warren County, Hickman County, Mayfield, Dawson Springs, Auburn and Pembroke who received their December benefits prior to the storms will receive automatic replacements. SNAP households not covered by this automatic replacement will need to call DCBS to request a replacement.

Kentuckians residing in the following counties may make hot food purchases through Jan. 17, 2022: Adair, Allen, Barren, Butler, Caldwell, Calloway, Carlisle, Casey, Christian, Crittenden, Daviess, Edmonson, Fulton, Graves, Green, Hancock, Hardin, Hart, Hickman, Hopkins, Larue, Livingston, Logan, Lyon, Marion, Marshall, McClean, McCracken, Metcalfe, Muhlenberg, Ohio, Simpson, Taylor, Todd, Trigg, Warren and Webster. Under normal circumstances, hot foods cannot be bought using SNAP benefits. SNAP authorized retailers have been notified of the approval that allows for this exception. Retailers may need 24 to 36 hours to make changes that will allow the sale of hot foods.

ELIGIBILITY

Small businesses and most private nonprofit organizations in the following adjacent counties are eligible to apply only for SBA Economic Injury Disaster Loans: Adair, Allen, Barren, Breckinridge, Butler, Calloway, Carlisle, Casey, Crittenden, Daviess, Edmonson, Grayson, Green, Hancock, Hardin, Larue, Livingston, Marion, McCracken, McLean, Metcalfe, Simpson, Todd, Trigg, and Webster in Kentucky; Mississippi and New Madrid in Missouri; and Henry, Lake, Montgomery, Obion, Robertson, Stewart and Weakley in Tennessee.

WHAT TYPES OF DISASTER LOANS ARE AVAILABLE?

- Business Physical Disaster Loans Loans to businesses to repair or replace disaster-damaged property owned by the business, including real estate, inventories, supplies, machinery and equipment. Businesses of any size are eligible. Private, non-profit organizations such as charities, churches, private universities, etc., are also eligible.
- Economic Injury Disaster Loans (EIDL) Working capital loans to help small businesses, small agricultural cooperatives, small businesses engaged in aquaculture, and most private, non-profit organizations of all sizes meet their ordinary and necessary financial obligations that cannot be met as a direct result of the disaster. These loans are intended to assist through the disaster recovery period.
- **Home Disaster Loans** Loans to homeowners or renters to repair or replace disaster-damaged real estate and personal property, including automobiles.

WHAT ARE THE CREDIT REQUIREMENTS?

- Credit History Applicants must have a credit history acceptable to SBA.
- Repayment Applicants must show the ability to repay all loans.

 Collateral – Collateral is required for physical loss loans over \$25,000 and all EIDL loans over \$25,000. SBA takes real estate

WHAT ARE THE INTEREST RATES?

By law, the interest rates depend on whether each applicant has Credit Available Elsewhere. An applicant does not have Credit Available Elsewhere when SBA determines the applicant does not have sufficient funds or other resources, or the ability to borrow from non-government sources, to provide for its own disaster recovery. An applicant, which SBA determines to have the ability to provide for his or her own recovery is deemed to have Credit Available Elsewhere. Interest rates are fixed for the term of the loan. The interest rates applicable for this disaster are:

WHAT ARE LOAN TERMS?

The law authorizes loan terms up to a maximum of 30 years. However, the law restricts businesses with credit available elsewhere to a maximum 7-year term. SBA sets the installment payment amount and corresponding maturity based upon each borrower's ability to repay.

WHAT ARE THE LOAN AMOUNT LIMITS?

- **Business Loans** The law limits business loans to \$2,000,000 for the repair or replacement of real estate, inventories, machinery, equipment, and all other physical losses. Subject to this maximum, loan amounts cannot exceed the verified uninsured disaster loss.
- Economic Injury Disaster Loans (EIDL) The law limits EIDLs to \$2,000,000 for alleviating economic injury caused by the disaster. The actual amount of each loan is limited to the economic injury determined by SBA, less business interruption insurance, and other recoveries up to the administrative lending limit. EIDL assistance is available only to entities and their owners who cannot provide for their own recovery from non-government sources, as determined by the U.S. Small Business Administration.
- Business Loan Ceiling The \$2,000,000 statutory limit for business loans applies to the combination of physical, economic injury, mitigation, and refinancing, and applies to all disaster loans to a business and its affiliates for each disaster. If a business is a major source of employment, SBA has the authority to waive the \$2,000,000 statutory limit.
- **Home Loans** SBA regulations limit home loans to \$200,000 for the repair or replacement of real estate and \$40,000 to repair or replace personal property. Subject to these maximums, loan amounts cannot exceed the verified uninsured disaster loss.

WHAT RESTRICTIONS ARE THERE ON LOAN ELIGIBILITY?

• **Uninsured Losses** – Only uninsured or otherwise uncompensated disaster losses are eligible. Any insurance proceeds which are required to be applied against outstanding mortgages are not available

- to fund disaster repairs and do not reduce loan eligibility. However, any insurance proceeds voluntarily applied to any outstanding mortgages do reduce loan eligibility.
- Ineligible Property Secondary homes, personal pleasure boats, airplanes, recreational vehicles, and similar property are not eligible unless used for business purposes. Property such as antiques and collections are eligible only to the extent of their functional value. Amounts for landscaping, swimming pools, etc., are limited.
- Noncompliance Applicants who have not complied with the terms of previous SBA loans may not be eligible. This includes borrowers who did not maintain flood and/or hazard insurance on previous SBA loans.

Note: Loan applicants should check with agencies/organizations administering any grant or other assistance program under this declaration to determine how an approval of SBA disaster loan might affect their eligibility.

IS THERE HELP WITH FUNDING MITIGATION IMPROVEMENTS?

If your loan application is approved, you may be eligible for additional funds to cover the cost of improvements that will protect your property against future damage. Examples of improvements include retaining walls, seawalls, sump pumps, etc. Mitigation loan money would be in addition to the amount of the approved loan, but may not exceed 20 percent of total amount of physical damage to real property, including leasehold improvements, and personal property as verified by SBA to a maximum of \$200,000 for home loans. It is not necessary for the description of improvements and cost estimates to be submitted with the application. SBA approval of the mitigating measures will be required before any loan increase.

IS THERE HELP AVAILABLE FOR REFINANCING?

- SBA can refinance all or part of prior mortgages that are evidenced by a recorded lien, when the applicant (1) does not have credit available elsewhere, (2) has suffered substantial uncompensated disaster damage (40 percent or more of the value of the property or 50% or more of the value of the structure), and (3) intends to repair the damage.
- **Businesses** Business owners may be eligible for the refinancing of existing mortgages or liens on real estate, machinery and equipment, up to the amount of the loan for the repair or replacement of real estate, machinery, and equipment.
- **Homes** Homeowners may be eligible for the refinancing of existing liens or mortgages on homes, up to the amount of the loan for real estate repair or replacement.

WHAT IF I DECIDE TO RELOCATE?

You may use your SBA disaster loan to relocate. The amount of the relocation loan depends on whether you relocate voluntarily or involuntarily. If you are interested in relocation, an SBA representative can provide you with more details on your specific situation.

ARE THERE INSURANCE REQUIREMENTS FOR LOANS?

To protect each borrower and the Agency, SBA may require you to obtain and maintain appropriate insurance. By law, borrowers whose damaged or collateral property is located in a special flood hazard area must purchase and maintain flood insurance. SBA requires that flood insurance coverage be the lesser of 1) the total of the disaster loan, 2) the insurable value of the property, or 3) the maximum insurance available.

PROGRAM DESCRIPTION

If you were impacted by a federally declared disaster, you may have extra time to file and pay your taxes currently due.

GENERAL PROGRAM REQUIREMENTS

Your account is automatically coded for filing and payment relief if you meet both of the following conditions:

- You live in a county identified by the IRS as qualified for disaster tax relief.
- Your address is up to date with the IRS.

You do not need to call or contact the IRS to get relief.

APPLICATION PROCESS

Please call the IRS disaster hotline at 1-866-562-5227 if you meet any of the conditions below.

You live in a federally declared disaster area and you are:

- Impacted by a federally declared disaster and your record of address is not up to date.
- Experiencing other tax-related hardships.
- Unable to make your installment agreement payments on back-due taxes.

IRS DISASTER ASSISTANCE AND EMERGENCY RELIEF FOR INDIVIDUALS AND BUSINESSES

Special tax law provisions may help taxpayers and businesses recover financially from the impact of a disaster, especially when the federal government declares their location to be a major disaster area. Depending on the circumstances, the IRS may grant additional time to file returns and pay taxes. Both individuals and businesses in a federally declared disaster area can get a faster refund by claiming losses related to the disaster on the tax return for the previous year, usually by filing an amended return.

The IRS also offers audio presentations on Planning for Disaster. These presentations discuss business continuity planning, insurance coverage, recordkeeping and other tips to stay in business after a major disaster.

- Get the Latest Tax Relief Guidance in Disaster Situations: Recent special tax law provisions may help taxpayers recover financially from the impact of a major disaster in their location.
- <u>Tax Topic 515 Casualty, Disaster, and Theft Losses</u>: Casualty losses can result from the destruction of or damage to your property from any sudden, unexpected, and unusual event such as a flood, hurricane, tornado, fire, earthquake or even volcanic eruption.

FEDERAL PROGRAMS

Most Kentucky agricultural producers may be eligible for federal programs from the U.S. Department of Agriculture due to losses directly related to the adverse weather events that occurred in the Commonwealth from December 10 - 11, 2021.

These programs are administered by the U.S. Department of Agriculture, not the Kentucky Department of Agriculture. TIP SHEET FOR AGRICULTURAL PRODUCERS

As recovery and reclamation efforts proceed, it is important producers do the best they can to document loss of private property, food, and/or agricultural products.

Take pictures and videos to document damage, especially water damage that may change before an inspection can take place. Before disposing of any damaged personal property, ruined food, or agricultural products due to lack of power or other causes, take photos to document it.

KENTUCKY AG DISASTER DONATIONS

The Kentucky Department of Agriculture and the University of Kentucky College of Agriculture, Food and Environment's Cooperative Extension Service are teaming up to coordinate an operation to identify the needs and supplies for individual farming operations in the impacted area.

Individuals in impacted areas should contact their county extension office, which will collect a list of needs from producers for their operation and provide that information to the KDA. The Department will then coordinate with farm organizations in the commonwealth and work to match the requested need with the donor of the item. This can include immediate needs such as hay or feed to longer-term items such as fencing material.

TREE DAMAGE CLEANUP

The December tornadoes and strong winds caused extensive damage to trees and woodlands across the state. As landowners begin the cleanup from these storms, it's important to remember to use extreme caution when entering any wooded areas full of storm-related hazards from downed powerlines and trees, storm debris, loose branches and hung-up stems high in the canopy. KENTUCKY BAR ASSOCIATION DISASTER PLAN

The Kentucky Bar Association has activated our Disaster Response Plan pursuant to Supreme Court Rule 3.130(7.60). The Disaster Response Plan addresses, "the problems that occur when lawyers and non-lawyers, who are not subject to the disciplinary jurisdiction of the Kentucky Bar Association and the Kentucky Supreme Court, engage in the provision of legal services, legal advice, and outright solicitation of persons and their families affected by a Disaster."

As part of the Kentucky Disaster Response plan, The Kentucky Mass Disaster Task Force is created. Members of the Task Force are Supreme Court of Kentucky Justice Christopher Shea Nickell of Paducah, Task Force Chair; Retired Circuit Judge and KBA Ethics Committee Chair Judge Paul Isaacs of Sadieville; KBA's Unauthorized Practice of Law Committee Chair attorney Rodger Lofton of Paducah, retired Supreme Court of Kentucky Justice Bill Cunningham of Kuttawa; and KBA Vice President W. Fletcher Schrock of Paducah.

Kentucky Revised Statute 21A.300 makes it a Class A misdemeanor for an attorney or an attorney referral service to directly solicit a victim or a relative of a victim of a disaster for 30 days following a disaster.

The Kentucky Supreme Court's Rules of Professional Conduct governing lawyer conduct make it a violation at any time for an attorney, or anyone on an attorney's behalf, to initiate contact or to solicit professional employment, in person or by live telephone, from a prospective client who is not a family member or a client of the attorney. Additionally, SCR 3.130(4.5)(4) provides that "no communication shall be sent to those individuals and related targets of solicitation who have been involved in a disaster as defined in SCR 3.130(7.60) until 30 days have elapsed from the occurrence of the Disaster."

If members of the public are not already aware, the public should know that "statutes of limitation" exist which apply to various causes of action within the Commonwealth of Kentucky and, in certain circumstances, to Federal causes of action. Further, any person or entity believing he or she has been damaged by the wrongful acts of another should seek legal advice to determine the applicable statute of limitations, and other rights.

Lawyers seeking to make direct written contact with family members should be aware of the Kentucky lawyer advertising rules which are Rules of Professional Conduct.
